**Principal Report**

*School Opening*

We had a smooth opening. The PTA did a terrific job during sneak preview.

We began with an enrollment of 843 students and we are currently at 884. Our class size has been increased to the state maximum number.

We were able to re-hire two part-time assistants.

Question: How many TAG students do we have?

Answer: Currently, we have 155 TAG students.

*Gating Entrances*

Jimmy asked the council for their thoughts of gating the entrances to our campus as we have been experiencing misuse of our campus and parking lot. Since there is no nearby park, families do use the playground facility. It was suggested that we contact the police department to patrol the area more frequently before moving to the idea of a fence.
